OPTION 1 DEFENSIVE DRIVING SCHOOL

Attending Defensive Driving School (DDS) allows **one civil moving violation** to be dismissed without going to court, paying a court fine, or having points assessed for that charge. For a Red-Light Violation or person under age 18 (first offense), you will not be required to attend Traffic Survival School (TSS).

You are eligible for DDS if:

- You have not attended DDS for a violation that occurred within 12 months of the currently alleged violation.
- The violation code written on your citation is listed on this slip, with an asterisk (*).
- Your traffic charge did not result from an accident involving death or serious physical injury, and
- You are not requesting a Civil Traffic Hearing on that charge.
- You hold a Commercial Driver License (CDL) but were driving a vehicle requiring a class D or M license and the vehicle was not being used for commercial purposes. If under such circumstances the CDL holder completes DDS, the violation will be reported to MVD but points will not be assessed on your driving record. A.R.S. §§ 28-3392(A)(2)(b) and 28-3394.01(A).

DDS Registration Instructions: To register for DDS, call the DDS information line at 1-888-334-5565 (automated response only) or visit www.azcourts.gov/drive to determine which DDS school you may attend and the fee for the school. You must complete DDS (whether online or in person) at least seven (7) days before your court date.

IF YOU REGISTER FOR DDS, FAILURE TO TIMELY COMPLETE THE COURSE MAY RESULT IN ADDITIONAL FINANCIAL SANCTIONS BEING IMPOSED AGAINST YOU AND A DEFAULT JUDGMENT BEING ENTERED AND REPORTED TO MVD, WHICH MAY IMPACT YOUR DRIVING RECORD OR VEHICLE REGISTRATION.

IMPORTANT NOTICE: Completion of Traffic Survival School (TSS) will not satisfy the Defensive Driving School (DDS) requirement.

INFORMATION FOR CERTAIN VIOLATIONS

<u>UNDER AGE 18 (FIRST OFFENSE)</u>: In addition to the fine, if you are found responsible or plead responsible for a moving violation, you will be required to attend Traffic Survival School (TSS).

A.R.S. 28-448 – FAILURE TO UPDATE ADDRESS: If you provide valid proof of address change filed with MVD, the Court will waive the fine.

A.R.S. 28-6453A & 28-647.1 – RED LIGHT VIOLATION: In addition to the fine, persons found responsible or who plead responsible for either of these red-light violations will be required by MVD to complete Traffic Survival School (TSS).

A.R.S. 28-907A – CHILD PASSENGER RESTRAINT: If you show proof of a child passenger restraint system or proof of purchase of a child passenger restraint system, the fine may be reduced to \$0.

A.R.S. 28-2532A – NO VEHICLE REGISTRATION: If you show proof of current registration on the vehicle, this charge will be dismissed.

A.R.S. 28-3151A & 28-3222 - DRIVER LICENSE REQUIREMENT: Upon proof of a current valid driver license, the fine will be waived.

A.R.S. 28-3169A - NO DRIVER LICENSE IN POSSESSION: Dismissed upon proof of driver license valid on the date and time of the violation. Mail or email a legible copy of the front and back of your driver license.

A.R.S. 28-3482A – DRIVING ON SUSPENDED LICENSE (CIVIL): Dismissed upon proof that your unrestricted privilege to drive has been reinstated by MVD.

A.R.S. 28-4135A - NO PROOF OF INSURANCE: If you did not have a valid policy on the date of violation the court may waive or reduce the penalty if you can show proof of BOTH:

- A. A current six-month policy of insurance
- B. A 39-month driving record from the Motor Vehicle Division (MVD) showing no previous violations of ARS 28-4135 within the last 24 months or one violation of ARS 28-4135 within the last 36 months

A.R.S. 28-4135B & C - NO PROOF OF INSURANCE: A violation results in a mandatory fine of \$975 plus a 3-month suspension of driving privileges. If before or on your appearance date you provide proof of insurance that was valid on the DATE and TIME the ticket was issued, the charge will be dismissed. If you did not have insurance on the violation date, you may be eligible for a reduced fine if you provide (1) proof that you purchased a six-month policy of insurance, and (2) a copy of your MVD driving record indicating that you have not been found responsible under §28-4135 within the past 24 months (or not more than once in the past 36 months).

You must appear in court if your citation was issued as a result of an accident involving death or a serious physical injury.

Failure to appear for a civil violation on or before your arraignment date will result in a default judgment being entered. There will be a \$25.00 default fee added to each charge plus a \$20.00 time payment fee per case. Your case will be sent to a collection agency which will result in additional fees, your credit and vehicle registration may also be affected. In addition, your Arizona State tax returns may also be impacted.

You may use the Defensive Driving Program for only one eligible moving violation code. If you received more than one violation code on your citation, the other violations must be resolved using options 2 or 3 or by appearing in court.
