

ORDINANCE NO. 23-34

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, APPROVING AND ADOPTING AN AMENDMENT TO THE CITY'S TRANSPORTATION CORRIDOR OVERLAY MAP, GENERALLY LOCATED BETWEEN HONEYCUTT ROAD AND W. DESERT CEDARS DR., AS DESCRIBED IN ZONING CASE #ZON 23-04.

WHEREAS, on November 4, 2014, the City adopted as a public record a new zoning code as part of the Maricopa City Code, which has been amended from time to time; and

WHEREAS, part of the Zoning Code includes a Transportation Corridor Overlay, which helps promote an appropriate mixture of activity that enhances the character of the major gateways and transportation corridors in the City; and

WHEREAS, with the completion of the SR 347 overpass in 2019, a section of right-of-way between Honeycutt Road and W. Desert Cedars Dr. was relocated east of the original alignment; and

WHEREAS, the Transportation Corridor Overlay should be realigned to be consistent with the current location of the right-of-way on SR 347; and

WHEREAS, the City's Planning and Zoning Commission held a public hearing on June 29, 2023 in zoning case #ZON 23-04, in the manner prescribed by law for the purpose of amending the City's Transportation Corridor Overlay Map.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Maricopa, Arizona as follows:

Section 1. That the Maricopa Transportation Corridor Overlay Map is hereby amended by realigning the overlay, generally located between Honeycutt Road and W. Desert Cedars Dr., to be consistent with the current location of the right-of-way on SR 347, as described in Exhibit A. The Development Services Department shall amend the Transportation Corridor Overlay Map to reflect this amendment, as described in Exhibit A, and one paper copy and one electronic copy of the revised map shall be maintained in compliance with A.R.S. § 44-7041 and available for public inspection during normal business hours in the Office of the City Clerk and shall be available on the City's website at: www.maricopa-az.gov.

Section 2. Further, those conditions of approval imposed by the Maricopa City Council as part of zoning case ZON 23-04 are hereby expressly incorporated into and adopted as part of this Ordinance by this reference.


Section 3. To the extent of any conflict between other City Ordinances and this Ordinance, this Ordinance shall be deemed to be controlling; provided, however, that this Ordinance is not intended to amend or repeal any existing City Ordinance, Resolution or regulation except as expressly set forth herein.

Section 4. This Ordinance shall become effective thirty (30) days from the date of

adoption by the City Council for the City of Maricopa.


